# ORDER:

Whereas, in the reference 2<sup>nd</sup> read above, under Reg.14(a)(1) of TSTRANSCO SRs Part-II, the following **10 (Ten)** Asst. Executive Engineers/Civil were promoted temporarily as Executive Engineers/ Civil for the panel drawn on 09.06.2017, keeping in view the exigencies of work and to suit administrative convenience:

- 2. The promotions ordered above were subject to the following conditions:
  - i. The promotions ordered in Para-1 above are purely temporary and liable for termination at any time without notice and without assigning any reasons thereto.
  - ii. The promotions ordered in Para-1 above are subject to result of WP. No.16660 of 2015 and batch pending in Hon'ble High Court of Judicature at Hyderabad for the State of Telangana and State of Andhra Pradesh.
- iii. The promotions ordered in Para-1 above are also subject to finalization of allocation of employees between APTRANSCO and TSTRANSCO and subsequent change in the seniority, if any.

- iv. The promotions ordered in Para-1 above are also subject to the condition that it shall be reviewed after completion of the process of final allocation of cadre strength, vacancies and employees between the successor States by the Government and the persons, so promoted meanwhile, shall not have any right on such promotion.
- 3. Whereas, as per the Judgments of the Hon'ble Supreme Court in the references read above, the allocation of employees between APTRANSCO & TSTRANSCO has attained finality. As such, in the reference 8<sup>th</sup> read above, the "inter-se-seniority" of the Petitioners vis-à-vis the employees working in TSTRANSCO as on 02-06-2014 has been fixed and drawn. Consequently, the previous seniority of AEEs/Civil., has undergone significant change, necessitating review of the panels drawn earlier based on the said seniority. As a result, the promotions ordered from the earlier panel dtd.09.06.2017 for promotion of AEEs/Civil as EEs/Civil shall also be required to be redrawn.
- 4. Therefore, the earlier panel dtd. 09.06.2017 drawn for promotion of the AEEs/Civil as EEs/Civil has been re-drawn taking into consideration the "Inter-se-Seniority" now fixed as on 02-06-2014.
- 5. After careful consideration, the TSTRANSCO has decided to cancel the promotions ordered in the reference 2<sup>nd</sup> read above, since the said promotions ordered therein were subject to the conditions as extracted at Para-2 above. Accordingly, the promotions ordered in respect of the following AEEs/Civil as EEs/Civil are hereby cancelled with immediate effect.
