ORDER:

Whereas, in the reference 1st read above, Smt T.Srilekha, Assistant Engineer (Elecl.) was notionally promoted as Assistant Divisional Engineer (Elecl.)

- 2. The above Notional promotion order was issued under APSEB Service Regulations Part-II as adopted by TS Transco subject to the following conditions.
 - (i) The Notional promotion is liable for termination at anytime without notice and without assigning any reasons therefor;
 - (ii) The Notional promotion is also subject to outcome of the WP No.16660 of 2015 and Batch pending in the Hon'ble High Court of Judicature at Hyderabad for the state of Telangana.
 - (iii) The Notional promotion is also subject to the finalization of allocation of employees between APTRANSCO & TSTRANSCO and subsequent change in the seniority, if any.
 - (iv) The Notional promotion shall be reviewed after completion of the process of final allocation of cadre strength, vacancies and employees between successor States by the Government and persons so promoted meanwhile shall not have any right on such promotion.
- 3. Whereas, as per the Judgments of the Hon'ble Supreme Court in the references read above, the allocation of employees between APTRANSCO & TSTRANSCO has attained finality. As such, in the reference 8th read above, the "inter-se-seniority" of the Petitioners vis-à-vis the employees working in TSTRANSCO as on 02-06-2014 has been fixed and drawn. Consequently, the previous seniority of AE (Elecl.) and ADE(Elecl.) have undergone significant change, necessitating review of the panels drawn earlier based on the said seniority. As a result, the Notional promotions ordered for promotion of Assistant Engineer (Elecl.) as Assistant Divisional Engineer (Elecl.) shall also be required to be re-drawn.

- 4. Therefore, the Notional promotion ordered earlier from Assistant Engineer (Elecl.) to Assistant Divisional Engineer (Elecl.) has been re-drawn taking into consideration the "Inter-se-Seniority" now fixed as on 02-06-2014.
- 5. After careful consideration, the TSTRANSCO has decided to cancel the notional promotion ordered in the reference 1st cited above, since the said notional promotion ordered therein was subject to the conditions as extracted at Para-2 above. Accordingly, the notional promotion ordered in respect of the following Assistant Engineer (Elecl.) as Assistant Divisional Engineer (Elecl.) is hereby cancelled with immediate effect:
