**ORDER:**

In the reference 3<sup>rd</sup> cited, the Director, Yashoda Hospitals, Malakpet, Hyderabad has preferred (2) Nos. credit medical bill amounting to Rs.1,24,361/- (Rupees One lakh twenty four thousand three hundred and sixty one only) towards the medical treatment extended to Sri K.Bhaskar Rao, ADE(Retd.), ID.No.1045170, O/o.SE/OMC Circle/Metro-Central/Hyderabad as in-patient for the period from 19.01.2021 to 21.01.2021 and 22.01.2021 to 25.01.2021 for “Surgery – I&D & Orthostatic Hypotension perianal abscess” and requested to issue cheque in favour of M/s. Yashoda Health Care Services Pvt. Ltd.

2. After careful examination and as per Medical Regulations 4(f) &9(2) of A.P.S.E.Board as adopted by TSTransco, the Chief General Manager (HRD) as per delegation of powers orders in T.O.O.Ms.No.301, dt.31.3.2009, read with Memo dt.22-10-2020, the hereby accords sanction for an amount of Rs.1,24,361/- (Rupees One lakh twenty four thousand three hundred and sixty one only) to Yashoda Hospitals, Malakpet, Hyderabad in full and final settlement of credit bills towards the medical charges mention in para 1 above.

3. The Pay Officer/TS Transco/VS/Hyderabad is requested to arrange for payment of Rs.1,24,361/- (Rupees One lakh twenty four thousand three hundred and sixty one only) to M/s. Yashoda Health Care Services Pvt. Ltd against their credit bill under intimation to the Chief General Manager (HRD), Vidyut Soudha, Hyderabad.

4. An amount of Rs.1,22,578/- is sanctioned to Sri K.Bhaskar Rao, ADE(Retd.), ID.No.1045170, O/o.SE/OMC Circle/Metro-Central/Hyderabad. A sum of Rs.1,782/- is recoverable from the pensioner. The SE/OMC Circle/Metro-Central/Hyderabad is requested to recover the amount accordingly in instalments from the pension of the pensioner towards the cost of inadmissible items and intimate the same with C.B. voucher No. to the Chief General Manager (HRD)TS Transco, within a month from the date of recovery from the pension of the pensioner concerned, failing which disciplinary action will be initiated against the concerned Pay Drawing Officer.
