In the reference 5th cited, the Director, Yashoda Hospitals, Malakpet, Hyderabad has preferred (1) No. credit medical bill amounting to Rs.31,463/- (Rupees Thirty one thousand four hundred and sixty three only) towards the medical treatment extended to Kum.M.Lakshmi D/o Sri M.Bikshapathy, Artisan Gr-II, ID.No.0556 O/o.SE/400KV/Const./Metro/ Hyderabad as in-patient from 26.08.2023 to 30.08.2023 for “Acute Febrile Illness” at Yashoda Hospitals, Malakpet, Hyderabad and requested to issue cheque in favour of M/s. After careful examination and Medical Regulations 4(f) & 9(2) of APSE Board as adopted by TS Transco and as per delegation of powers ordered in TOO.Ms.No.301, dt.31.3.2009 and read with memo dt:22.10.2020, the Deputy Secretary (HRD) hereby accords sanction for an amount of Rs.31,113/- (Rupees Thirty one thousand one hundred and thirteen only) for reimbursement of medical charges to Yashoda Hospitals, Malakpet, Hyderabad in full and final settlement of credit bill towards the medical charges mentioned in para 1 above duly deducting an amount of Rs.350/- (Rupees Three hundred and fifty only) towards the excess amount claimed by Yashoda Hospitals, Malakpet, Hyderabad.

The Pay Officer/TS Transco/VS/Hyderabad is requested to arrange for payment of Rs.31,113/- (Rupees Thirty one thousand one hundred and thirteen only) (from general ceiling) to M/s.Yashoda Health Care Services Pvt. Ltd against their credit bill under intimation to the Chief General Manager (HRD)/TS Transco, Vidvut Soudha, Hyderabad.

4. An amount of Rs.31,113/- is sanctioned to Sri M.Bikshapathy, Artisan Gr-II, ID.No.0556 O/o.SE/400KV/Const./Metro/ Hyderabad.
