After careful examination under Medical Regulations 4(f) & 9(2) of APSE Board as adopted by TSTransco, and as per delegation of powers ordered in TOO.Ms.No.301, dt.31.03.2009 read with Memo dt.22-10-2020, the Chief General Manager (HRD) hereby accords sanction for an amount of Rs.78,988/- (Rupees Seventy Eight Thousand Nine Hundred and Eighty Eight only) for reimbursement of medical charges to Yashoda Hosptals, Malakpet, Hyderabad in full and final settlement of credit bill towards the medical charges mentioned in para 1 above duly deducting an amount of Rs.2.00/- (Rupees Two only) towards the excess amount claimed by Yashoda, Hospitals, Malakpet, Hyderabad.
