### **ORDER:**

Under Regulation-14(a)(1) of TSTRANSCO Service Regulations Part-II, SmtM.Urmila Devi, Deputy Secretary is promoted as Joint Secretary with effect from the date of assumption of charge.

The promotion ordered in Para-1 above is subject to review as per the Clarification dtd.29.05.2021 issued by the Government of Telangana with regard to fixation of seniority based on "merit ranking"; and also in terms of the Circular Memo dtd.24-10-2019 issued by the Scheduled Castes Development Department, Government of Telangana on the implementation of the rule of reservation to SCs/STs in promotions conferring "consequential seniority" or otherwise and implementation of "catch-up rule".
