ORDER:

In pursuance to the notices issued by the EPFO,Kukatpally an amount of Rs.8,57,438/- (i.e., Rs.2,92,326/- towards 7Q interest & Rs.5,65,112/- towards 14B damages) had been remitted to EPFO on belated remittance of EPF contributions in respect of Smt.M.Savitha,JPO(Now PO) for the period from 01.08.2014 o 30.06.2020 and a letter has been addressed for reconciliation of the balance amount to be remitted.

2) In the reference 4<sup>th</sup> cited the EPFO, Kukatpally has issued another notice for payment of balance amount of Rs.1,28,459/- (i.e., Rs.89,593/- towards 7Q interest and Rs.38,866/- towards 14B damages) for the period from 04/2016 to 12/2016 which pertains to other regular employees.

3) After careful consideration, sanction is hereby accorded for arranging payment of Rs.23,401/- (i.e., Rs.16,116.00 towards 7Q interest and Rs.7,285.00 towards 14B damages) initially and the remaining amount of interest and damages is payable after reconciliation and getting confirmation from the EPFO Authorities.

4) The Pay Officer/TSTRANSCO is hereby authorized to remit the amount of Rs. 23,401/- (i.e., Rs.16,116/- towards damages and Rs.7,285/- towards interest) to EPFO, Kukatpally, Hyderabad.

5) The said expenditure is chargeable to Account No.750813.

6) The said sanction is registered with item No. 25/2020-21.
