ORDER:

Consequent to enactment of Andhra Pradesh Electricity reform Act, 1998, the APTRANSCO has been incorporated under the provisions of companies, act, 1956 w.e.f. 01/02/1999 and employees who were appointed on or after 01/02/1999 were allotted with EPF no and their monthly contributions are being remitted to EPFO.

2. Smt.M.Savitha, JPO appointed on 7/7/2000 at CTI/Erg/Hyd was being continued in GPF instead of EPF. The TSTransco has decided to stop the monthly GPF recovery in respect of Smt.M.Savitha, JPO w.e.f. 01/07/2020, and to remit the monthly contributions to EPFO with retrospective date of her joining i.e., w.e.f. 07/07/2000 to 30/06/2020 duly obtaining a fresh EPF account on her name to enable her eligible for pensionary benefits and other benefits under EPF scheme.

3. The EPFO/Kukatpally has allotted EPF No. 101518695007 to Smt.M.Savitha, JPO and accorded permission for remittance of EPF amount vide reference 2<sup>nd</sup> cited for the period from 07/07/2000 to 31/07/2014 under existing unit code SAO/CTI/Erragadda/Hyd and for the period from 01/08/2014 to 30/06/2020 for remittance under centralised HQ unit code AP/KKP/1001018. The EPFO/Kukatpally has levied Rs.8,39,284/- towards damages and Rs.5,35,038/- towards interest for the delayed remittance pertaining to the period from 01/08/2014 to 30/06/2020 under centralised HQ unit code AP/KKP/1001018, out of which certain amounts are under reconciliation with EPFO.

4. After careful consideration, sanction is hereby accorded for arranging payment of Rs. 5,65,112/- towards damages and Rs.2,92,326/- towards interest to the EPFO, Kukatpally, Hyderabad for the centralised HQ unit code AP/KKP/1001018.

5. The Pay Officer/TSTRANSCO is hereby authorized to remit the amount of Rs. 8,57,438/- (i.e., Rs.5,65,112/- towards damages and Rs.2,92,326/- towards interest) to EPFO, Kukatpally, Hyderabad.
