In the reference cited, it was informed that, the contract of Supply, Erection, Testing and commissioning of 400kV Quad Moose DC Line from 400kV Dichpally SS to 400kV Nirmal SS of length 60kM(approx.) on “TURNKEY” was awarded to M/s.Larsen & Toubro Limited, Chennai and Procurement of the Design Softwares detailed in U.O dated 22.11.2019 including training and other related Hardware was included in the scope of the subject as requested by CE/Transmission. The same was approved duly scrutinized by Construction wing and Civil wing and dispatch instructions were also issued.

2. Further M/s.Larsen & Toubro Limited, Chennai have offered M/s.Power Line Systems Inc., PLS-CADD, PLS POLE & PLS TOWER training schedule at Sharjah from 07.12.2019 to 12.12.2019 and requested to provide the details of the 3 Nos. representatives.

The total travelling expenditure to be borne by M/s.Larsen & Toubro Limited, Chennai towards inspection i.e. visa expenses, to and fro air fare charges from Hyderabad(India) to Sharjah (UAE), Boarding, Lodging and local transportation required for training program on design softwares i.e., PLS-CADD, PLS-TOWER, PLS-POLE in Sharjah(UAE). The DA & equipment allowances and other allowances shall be borne by TSTransco.
