In the reference 4th cited, the Director, Medicovert Hospital (A unit of Sahrudaya Healthcare Pvt. Ltd), Madhapur, Hyderabad has preferred (1) No. credit medical bill amounting to Rs.1,08,454/- (Rupees One lakh eight thousand four hundred and fifty four only) towards the medical treatment extended to Smt G.Marthamma M/o Sri G.Laxmaiah, Artisan Gr.II, ID.No.3361 O/o.SE/OMC/Sangareddy as in-patient from 23.07.2021 to 24.07.2021 for “Pylonephritis with AKI, Septic Shock, DJ Stenting MM” at Medicovert Hospital (A unit of Sahrudaya Healthcare Pvt. Ltd), Madhapur, Hyderabad and requested to issue cheque in favour of Sahrudaya Healthcare Pvt. Ltd.

After careful examination and Medical Regulations 4(f) & 9(2) of APSE Board as adopted by TS.Transco, the Chief General Manager (HRD) as per delegation of powers ordered in TOO.Ms.No.301, dt.31.3.2009, read with memo dt:22.10.2020 hereby accords sanction for an amount of Rs.1,08,103/- (Rupees One lakh eight thousand one hundred and three only) for reimbursement of medical charges to Medicover Hospital (A unit of Sahrudaya Healthcare Pvt. Ltd), Madhapur, Hyderabad in full and final settlement of credit bill towards the medical charges mentioned in para 1 above duly deducting an amount of Rs.351/- (Rupees Three hundred and fifty one only) towards the excess amount claimed by Medicover Hospital (A unit of Sahrudaya Healthcare Pvt. Ltd), Madhapur, Hyderabad.

3. The Pay Officer/TS Transco/VS/Hyderabad is requested to arrange for payment of Rs.1,08,103/- (Rupees One lakh eight thousand one hundred and three only) to Sahrudaya Healthcare Pvt. Ltd. against their credit bill under intimation to the Chief General Manager (HRD)/TS Transco, Vidyut Soudha, Hyderabad.

4. An amount of Rs.1,02,208/- is sanctioned to Sri G.Laxmaiah, Artisan Gr.II, ID.No.3361 O/o.SE/OMC/Sangareddy. A sum of Rs.5895/- is recoverable from the artisan. The SE/OMC/Sangareddy is requested to recover amount from the salary in installments accordingly and after recovery of the total amount intimate the same with C.B.Voucher No. to the Chief General Manager (HRD)TS Transco within a month from the last date of recovery from the salary of the artisan concerned, failing which disciplinary action will be initiated against the concerned Pay Drawing Officer/Concerned Disbursing Officers.
