ORDER:

In the reference 3rd cited, the Director, Yashoda Hospital, Secunderabad has preferred (1) No. credit medical bill amounting to Rs.2,38,823/- (Rupees Two lakhs thirty eight thousand eight hundred and twenty three only) towards the medical treatment extended to Sri G.Venkateswar Rao, ADE-2/Shift/220 KVSS/Ghanapur, ID.No.1047595, O/o.SE/OMC/Metro-East/Hyderabad as in-patient for the period from 13.08.2020 to 17.08.2020 for “Acute LRTI, Covid-19 (Medical Management)” at Yashoda Hospital, Secunderabad and requested to issue cheque in favour of M/s.Yashoda Health Care Services Private Limited.

2. After careful examination under Medical Regulations 4(f) & 9(2) of APSE Board as adopted by TS Transco and as per delegation of powers ordered in TOO.Ms.No.301, dt.31.3.2009 and read with Memo dt.22-10-2020, the Chief General Manager (HRD) hereby accords sanction for an amount of Rs.1,63,807/- (Rupees One lakh sixty three thousand eight hundred and Seven only) to Yashoda Hospital, Secunderabad in full and final settlement of credit bills towards the medical charges mentioned in para 1 above duly deducting an amount of Rs.75,016 /- (Rupee Seventy five thousand and sixteen only) towards the excess amount claimed by Yashoda Hospital, Secunderabad.

3. The Pay Officer/TS Transco/VS/Hyderabad is requested to arrange for payment of Rs.1,63,807/- (Rupees One lakh sixty three thousand eight hundred and Seven only) to M/s.Yashoda Health Care Services Private Limited against their credit bills under intimation to the Chief General Manager (HRD)/TS Transco, Vidyut Soudha, Hyderabad.

4. An amount of Rs.1,57,646/- is sanctioned to Sri G.Venkateswar Rao, ADE-2/Shift/220 KVSS/Ghanapur, ID.No.1047595, O/o.SE/OMC/Metro-East/Hyderabad. A sum of Rs.6,161/- is recoverable from the employee. The Pay Officer/VS/Hyderabad is requested to recover the amount accordingly in instalments from the salary of the employee towards the cost of inadmissible items and intimate the same with C.B. voucher No. to the Chief General Manager (HRD), within a month from the date of recovery from the salary of the employee concerned, failing which disciplinary action will be initiated against the concerned Pay Drawing Officer.
