In the reference 4th cited, the Director, Medicoover Hospital (A unit of Sahrudaya Healthcare Pvt. Ltd), Madhapur, Hyderabad has preferred (2) Nos. credit medical bill amounting to Rs.2,15,663/- (Rupees Two lakhs fifteen thousand six hundred and sixty three only) towards the medical treatment extended to Sri G.Ramulu Ramreddy F/o Sri Harshavardhan Reddy, Artisan Gr-I, ID.No.3188 O/o.SE/OMC/Mahabubnagar as in-patient from 03.08.2022 to 11.08.2022 & 31.08.2022 to 07.09.2022 for “Chronic Lacunar Infarct in Right Caudate Nucleus, C3-C6 L3-S1 Disc Indentation (MM)” “Surgery – Laminectomy + Discectomy” & “L4-L5 PIVD with Secondary Cancal Stensosis” at Medicoover Hospital (A unit of Sahrudaya Healthcare Pvt. Ltd), Madhapur, Hyderabad and requested to issue cheque in favour of Sahrudaya Healthcare Pvt. Ltd.

2. After careful examination and Medical Regulations 4(f) & 9(2) of APSE Board as adopted by TS.Transco, the Chief General Manager (HRD) as per delegation of powers ordered in TOO.Ms.No.301, dt.31.3.2009, read with memo dt:22.10.2020 hereby accords sanction for an amount of Rs.1,95,410/- (Rupees One lakh ninety five thousand four hundred and ten only) for reimbursement of medical charges to Medicover Hospital (A unit of Sahrudaya Healthcare Pvt. Ltd), Madhapur, Hyderabad in full and final settlement of credit bill towards the medical charges mentioned in para 1 above duly deducting an amount of Rs.20,253/- (Rupees Twenty thousand two hundred and fifty three Only) towards the excess amount claimed by Medicover Hospital (A unit of Sahrudaya Healthcare Pvt. Ltd), Madhapur, Hyderabad.

3. The Pay Officer/TS Transco/VS/Hyderabad is requested to arrange for payment of Rs.1,95,410/- (Rupees One lakh ninety five thousand four hundred and ten only) (from SFMS FY 2022-23) to Sahrudaya Healthcare Pvt. Ltd. against their credit bill under intimation to the Chief General Manager (HRD)/TS Transco, Vidyut Soudha, Hyderabad.

4. An amount of Rs.1,92,420/- is sanctioned to Sri Harshavardhan Reddy, Artisan Gr-I, ID.No.3188/O/o.SE/OMC/Mahabubnagar. A sum of Rs.2990/- is recoverable from the artisan. The SE/OMC/Mahabubnagar is requested to recover amount from the salary accordingly and after recovery of the total amount intimate the same with C.B.Voucher No. to the Chief General Manager (HRD)TS Transco within a month from the last date of recovery from the salary of the artisan concerned, failing which disciplinary action will be initiated against the concerned Pay Drawing Officer/Concerned Disbursing Officers.
