In the reference 1st cited, orders were issued for sanctioning an amount of 51,290/- (Rupees Fifty one thousand two hundred and ninety only) towards payment of annual premium (including medical coverage and GST) to M/s.National Insurance Company Limited, Secunderabad @Rs.2,230/-for each person for renewal of Group Personal Accident Insurance Coverage of Rs.15,00,000/- each (or) 72 times of the gross pay of the individual, whichever is less, to the (23 Nos.) trained staff working in Hotlines Wing of TS Transco for a further period of one year from 10.09.2020 to 09.09,2021

- 2. In the reference 2nd cited, orders were issued for Additional Group Personal Accident Insurance Coverage of Rs.35,00,000/- each to the existing GPA Insurance of Rs.15 Lakhs each for the Existing Trained Hotline Staff 20 Nos. and New Group Personal Accident Insurance Coverage of Rs.50.00 lakhs each to newly joined 4 Nos. trained staff working in Hotlines wing, TSTRANSCO, totaling 24 Nos for a period of one year (25.02.2021 to 24.02.2022) from M/s.Oriental Insurance Company.
- 3. The Chief Engineer/Transmission/TSTransco vide references 3rd & 4th cited has submitted approved proposal for payment of Group Personal Accident Insurance Policy to M/s.Oriental Insurance Company for a period from 10.09.2021 to 24.02.2022, and requested for payment of annual premium of Rs. 40,870/- (including medical coverage and GST) @ Rs.2,151/- to each staff for renewal of Group Personal Accident Insurance policy of Rs.15,00,000/- each to 19 Nos. Trained Hot Line Staff of TS Transco, for a further period from 10.09.2021 to 24.02.2022, so that a single fresh policy of 50 Lakhs as approved, can be purchased from next year onwards.
- 4. After careful examination, the TSTransco hereby accords approval for sanction of an amount of Rs.40,870/- (Rupees forty thousand eight hundred and seventy only) towards payment of annual premium (including medical coverage and GST) to M/s.Oriental Insurance Company @ Rs.2,151/-for each person for renewal of Group Personal Accident Insurance Coverage of Rs.15,00,000/- each to 19 Nos. Hot Lines Trained Staff working in Hot Lines wing of TS Transco (as per the enclosed Annexure) for a further period from 10.09.2021 to 24.02.2022.

- The amount sanctioned in para (4) above is subject to the Budget Provision to be made by the Chief Engineer/Transmission/Vidyut Soudha, Hyderabad.
- The Chief Engineer/Transmission is requested to take necessary action for payment of insurance premium sanctioned above, and get the insurance covered for the sum assured to all the Employees working in Hot Lines and further requested to extend this Group Personal Accident Insurance coverage for the Hotlines trained persons joining the Hotlines wing in future.
