ORDER:

TSTRANSCO has issued Notification for filling up of 1100 Junior Linemen vacancies in various OMC Circles of TSTRANSCO vide Notification No.04/2017, Dated 28.12.2017 and the ranks of the qualified candidates were declared on 18.09.2021.

2. After careful examination, the Selection Committees are hereby constituted Circle-wise with the Officers of TSTRANSCO as mentioned in Annexure-I for Verification of Original Certificates and for conducting Tower Climbing test.

3. The Verification of Original Certificates and Tower climbing test shall be conducted from 04.10.2021 to 07.10.2021. The list of provisionally selected candidates Circle-wise along with schedule for verification of Original Certificates and Tower Climbing test will be communicated separately. The Officers nominated in the Selection Committees are directed to be available on the respective dates with all necessary arrangements in advance for conducting the Verification of Original certificates and Tower Climbing test as per the guidelines issued in Annexures –II & III.

4. If the Original Certificates are not in order as per the application form submitted by the candidate at the time of applying for the post of JLM (will be sent by Corporate Office), the candidates shall not be allowed to the Tower climbing test. The list of Original Certificates to be verified is enclosed herewith in Annexure-II.

5. The candidate has to climb up 220KV Tower from one leg then climb over the bottom cross arm and climb down from the other leg (using angle pieces only while climbing up/down but not on Step bolts). The candidate should not rest while climbing up or down and if he/she rests, the candidate shall be disqualified. Steps/Safety Measures to be taken while conducting Tower Climbing test are enclosed herewith in Annexure-III.

6. The Superintending Engineers/OMCs after conducting the verification of certificates and Tower climbing test, shall communicate the list of qualified and unqualified candidates (along with reasons for disqualification), on the same day of the test, to the Corporate Office with the approval of the concerned Selection Committee in the Proforma enclosed herewith in Annexure-IV.
