## **ORDER:**

In the reference 1<sup>st</sup> cited it is informed that, in the letter dt: 20.02.2019 the Manufacturing clearance and Quality Assurance plan was issued to M/s. Siemens Ltd., for 220kV, 1000 Sqmm Outdoor type Cable end Terminations (Sealing ends) and 220 Kv ,1000 Sqmm GIS SF6 Terminations of make M/s LS Cables & Systems Ltd, South Korea.

- 2. Further, M/s Siemens Ltd, Gurgaon vide letter dated.24.05.2018 has informed that a) 9Nos.220kV,1000 Sqmm Outdoor type Cable end Terminations (Sealing ends) with spares 2 Nos. and b) 15 Nos. 220 kV,1000 Sqmm GIS SF6 Terminations with spares 3 Nos, ready for inspection at M/s. LS Cables & Systems Ltd, Gongdan-don, Gumi-si, South Korea.
- In the reference 2<sup>nd</sup> cited, it is informed that, in the PO No.209/OM-11, dt:29.09.2018, Contract was awarded to M/s Megha Engineering and Infrastructures Ltd. Hyderabad against Execution of 400 /220/132 KV GIS Sub-station at Rayadurg and 400/220/132 KV connectivity of 400 KV Rayadurg SS on turnkey basis, which includes 400kV 2500 Sqmm XLPE UG Cables, 220kV UG Cables and Accessories.
- 4. Further, M/s Megha Engineering & Infrastructures Ltd, Hyderabad vide their letter dt:16.07.2019 have offered for inspection of 220KV XLPE UG Cable accessories for execution of LILO of 220 KV Gachibowli, Shapurnagar, S/C Line to proposed Rayadurg SS and LILO of 220 KV Gachibowli, Erragadda S/C Line to proposed Rayadurg SS at M/s. LS Cables & Systems Ltd, Gongdan-don, Gumi-si, South Korea.

Taihan Electric Wire Company Ltd., Dangjin-si Chungchungnamdo, South Korea.

- 6. The total travelling expenditure, boarding and lodging for deputing officers shall be borne by Turnkey contractors. The DA & equipment allowances and other allowances shall be borne by TS Transco.
- 7. The TSTransco accords sanction for deputation of Sri.C.
