In the reference 4th cited, the job of conducting written examination in regard to direct recruitment of Assistant Engineer (Elect., Civil & Telecom) was entrusted to JNTU, Hyderabad @ 180/- + GST per each registered candidate.

2. The following terms of payment were informed to the University in the above letter.

Terms & Conditions:

The prices shall be FIRM in Rupees. Rs.180/- (two sets) plus GST per registered candidate subject to a minimum of Rs.20 Lakh plus GST for AE/Electrical and Rs.20 Lakh plus GST for AE/Telecom & Civil for conducting the written examination to the direct recruitment of Assistant Engineers.

TERMS OF PAYMENT :

- a) Advance of 50% of Pro-rata amount will be paid after last date of submission of applications, to take up the examination work. Remaining 50% of Pro-rata amount to be paid after receipt of results and merit lists. The amount payable is based on the no. of applicants registered for the examination.
- b) Submission of invoice and advance stamped receipt to be made in favour of the Pay Officer/TSTRANSCO/VS/Hyd., for arranging payment.
- c) For the balance 50% also, advance stamped receipt to be made in favour of the Pay Officer/TSTRANSCO/VS/Hyd., for arranging payment. The payment will be arranged through crossed cheque in favour of JNTU, Hyderabad.
