ORDER:

In the reference 4th cited, the Director of Satya Kidney Centre & Super Speciality Hospitals, Himayatnagar, Hyderabad has preferred (1) No.credit medical bill amounting to Rs.30,482/-(Rupees Thirty Thousand Four Hundred and Eighty Two only) towards the medical treatment extended to Smt.K.Anthamma, M/o.Sri.K.Surender Reddy, AE/AEE, ID:No.1071906, O/o.SE/OMC-Circle/Sangareddy as Inpatient from dt.04-08-2023 to 08-08-2023 for “Severe left sided Colicky Pain, left Upper Ureteric calculus with HUN (MM)” at Satya Kidney Centre & Super Speciality Hospitals, Himayatnagar, Hyderabad and requested to issue cheque in favour of “Satya Nursing Home Limited”.

After careful examination under Medical Regulations 4 (f) and 9 (2) of APSE Board adopted by TS Transco and as per delegation of powers ordered in TOO.Ms.No.301,dt.31.03.2009 read with Memo, dt.22.10.2020 the Deputy Secretary (HRD) hereby accords sanction for an amount of Rs.28,154/-(Rupees Twenty Eight Thousand One Hundred and Fifty Four Only) from General Ceiling to Satya Kidney Centre & Super Speciality Hospitals, Himayatnagar, Hyderabad in full and final settlement of credit bill towards the medical charges mentioned in para 1 above duly deducting an amount of Rs.2,327/- (Rupees Two Thousand Three Hundred and Thirty Seven Only) towards the excess amount claimed by Satya Kidney Centre & Super Speciality Hospitals, Himayatnagar, Hyderabad.

The Pay Officer/TSTransco/VS/Hyderabad is requested to arrange for payment of Rs.28,154/-(Rupees Twenty Eight Thousand One Hundred and Fifty Four Only) from General Ceiling Satya Nursing Home Limited against their credit bills under intimation to the Chief General Manager (HRD)/TS Transco, Vidyut Soudha, Hyderabad.

An amount of Rs.26,696/- is sanctioned to Sri.K.Surender Reddy, AE/AEE, ID:No.1071906, O/o.SE/OMC-Circle/ Sangareddy, a sum of Rs.1,458/- is recoverable from the employee, the SE/OMC-Circle/Sangareddy is requested to recover the amount from the salary of the employee towards the cost of inadmissible items and intimate the same with C.B Vocher No.to the CGM(HRD)/TSTransco,within a month from the date of recovery from the salary of the employee concerned failing which disciplinary action will be initiated against the concerned Pay Drawing Officer.
