ORDER:

In the reference 3rd cited, the Director, Omega Hospitals, Hospitals, Banjara Hills, Hyderabad has preferred (1) No. credit medical bill amounting to Rs.78,064/- (Rupees Seventy eight thousand and sixty four only) towards the medical treatment extended to Smt.L.Kavitha, M/o. Kum.Sarika Lakkakula, AE-3/Shift/220 KV SS/Sivarampally, O/o.SE/OMC/Metro-East/Hyderabad as in-patient for the period on 11.08.2020 for “Ca.Breast Chemotherapy” at Omega Hospitals, Banjara Hills, Hyderabad and requested to issue cheque in favour of Hyderabad Institute of Oncology Private Limited.

After careful examination under Medical Regulations 4(f) & 9(2) of APSE Board as adopted by TS Transco and as per delegation of powers ordered in TOO.Ms.No.301, dt.31.3.2009 read with Memo dt.22-10-2020, the Chief General Manager (HRD) hereby accords sanction for an amount of Rs.78,064/- (Rupees Seventy eight thousand and sixty three only) to Omega Hospitals, Banjara Hills, Hyderabad in full and final settlement of credit bills towards the medical charges.

3. The Pay Officer/TS Transco/VS/Hyderabad is requested to arrange for payment of Rs.78,064/- (Rupees Seventy eight thousand and sixty three only) to Hyderabad Institute of Oncology Private Limited against their credit bills under intimation to the Chief General Manager (HRD)/TS Transco, Vidyut Soudha, Hyderabad.

4. An amount of Rs.73,286/- is sanctioned to Kum.Sarika Lakkakula, AE-3/Shift/220 KV SS/ Sivarampally, O/o.SE/OMC/Metro-East/Hyderabad, I.D No.1073055. A sum of Rs.4,778/- is recoverable from the Employee. The SE/OMC/Metro-East/Hyderabad is requested to recover the amount accordingly in instalments from the salary of the employee towards the cost of inadmissible items and intimate the same with C.B. voucher No. to the Chief General Manager (HRD)TS Transco, within a month from the date of recovery from the salary of the pensioner concerned, failing which disciplinary action will be initiated against the concerned Pay Drawing Officer.
