ORDER:

In the reference 4<sup>rd</sup> cited, the Director, Yashoda Hospitals, Malakpet, Hyderabad has preferred (1) No. credit medical bill amounting to Rs.89,656/- (Rupees Eighty Nine Thousand and Six Hundred and Fifty Six only) towards the medical treatment extended to Smt.M.Seetamma, M/o.Sri.M.Chandra Sekhar Reddy, Artisan Gr-I, ID:No.50001177, O/o.SE/OMC-Circle/Nalgonda as in-patient from 07.10.2023 to 12.10.2023 for “Acute Febrile Illness Viral Pyrexia (MM)” at Yashoda Hospitals, Malakpet, Hyderabad and requested to issue cheque in favour of “M/s Yashoda Health Care Services Pvt Ltd”.

2. After careful examination under Medical Regulations 4(f) & 9(2) of APSE Board as adopted by TSTransco, and as per delegation of powers ordered in TOO.Ms.No.301, dt.31.03.2009 read with Memo dt.22-10-2020, the Chief General Manager (HRD) hereby accords sanction for an amount of Rs.89,655/- (Rupees Eighty Nine Thousand Six Hundred and Fifty Five only) for reimbursement of medical charges to Yashoda Hosptals, Malakpet, Hyderabad in full and final settlement of credit bill towards the medical charges mentioned in para 1 above.

3. The Pay Officer/TSTransco/VS/Hyderabad is requested to arrange for payment of Rs.89,655/- (Rupees Eighty Nine Thousand Six Hundred and Fifty Five only) from general ceiling to M/s Yashoda Health Care Services Pvt Ltd, against their credit bills under intimation to the Chief General Manager (HRD)/ TS Transco, Vidyut Soudha, Hyderabad.

4. An amount of Rs.89,256/- is sanctioned Sri.M.Chandra Sekhar Reddy, Artisan Gr-I, ID:No.50001177, O/o.SE/OMC-Circle/Nalgonda. A sum of Rs.399/-is recoverable from the Artisan the SE/OMC-Circle/Nalgonda is requested to recover the amount accordingly from the salary of the Artisan towards the cost of inadmissible items and intimate the same with C.B. voucher No. to the CGM(HRD)/TSTransco, within a month from the date of recovery from the salary of the artisan concerned, failing which disciplinary action will be initiated against the concerned Disbursing Officers.
