**ORDER:**

In the reference 3<sup>rd</sup> cited, the Director, Krishna Institute of Medical Sciences, Secunderabad has preferred (1) No. credit medical bill amounting to Rs.82,749/- (Rupees Eighty two thousand seven hundred and forty nine only) towards the medical treatment extended to Sri M.Narsimha Reddy, FM Gr-I, ID.No.1048183, O/o. SE/OMC Circle/Metro-Central/Hyderabad for the period on 31.12.2020 to 04.01.2021 for “Surgery TURP, Bladder neck excision & MM” and requested to issue cheque in favour of Krishna Institute of Medical Sciences Limited.

2. After careful examination and as per Medical Regulations 4(f) & 9(2) of A.P.S.E.Board as adopted by TSTransco, the Chief General Manager (HRD) as per delegation of powers orders in T.O.O.Ms.No.301, dt.31.3.2009, read with Memo dt.22-10-2020, the hereby accords sanction for an amount of Rs.82,220/- (Rupees Eighty two thousand two hundred and twenty only) to Krishna Institute of Medical Sciences, Secunderabad in full and final settlement of credit bill towards the medical charges mentioned in para 1 above duly deducting an amount of Rs.529/- (Rupees Five hundred and twenty nine only) towards the excess amount claimed by Krishna Institute of Medical Sciences, Secunderabad.

The Pay Officer/TS Transco/VS/Hyderabad is requested to arrange for payment of Rs.82,220/- (Rupees Eighty two thousand two hundred and twenty only) to Krishna Institute of Medical Sciences Limited against their credit bill under intimation to the Chief General Manager (HRD), Vidyut Soudha, Hyderabad.

4. An amount of Rs.74,726/- is sanctioned to Sri M.Narsimha Reddy, FM Gr-I, ID.No.1048183, O/o. SE/OMC Circle/Metro-Central/Hyderabad. A sum of Rs.7,494/- is recoverable from the Employee. The Pay Officer/V.S./Hyderabad is requested to recover the amount accordingly in instalments from the salary of the employee towards the cost of inadmissible items and intimate the same with C.B. voucher No. to the Chief General Manager (HRD)TS Transco, within a month from the date of recovery from the salary of the pensioner concerned, failing which disciplinary action will be initiated against the concerned Pay Drawing Officer.
