ORDER:

In the reference 4<sup>th</sup> cited, the Director, Yashoda, Hitech-City, Hyderabad has preferred (3) No. credit medical bill amounting to Rs.1,05,077/- (Rupees One Lakh Five Thousand and Seventy Seven only) towards the medical treatment extended to his Father Sri N. Pavan Kumar, Artisan Gr-II, ID: No. 50004551, O/o SE/OMC-Circle/Nalgonda for the treatment to for “Viral fever with Thrombocytopenia, Bilateral Lower Limb Cellulitis (MM)”, “Acute Febrile Illness (MM)” and “Viral Pyrexia (MM)” as in patient from 01.10.2023 to 04.10.2023, 01.10.2023 to 04.10.2023 & 02.10.2023 to 04.10.2023 at Yashoda, Hitech-City, Hyderabad and requested to issue cheque in favour of M/s Yashoda Health Care Services Pvt Ltd.

2. After careful examination under Medical Regulations 4(f) & 9(2) of APSE Board as adopted by TS Transco and as per delegation of powers ordered in TOO.Ms.No.301, dt.31.03.2009 read with Memo dt.22-10-2020, the Chief General Manager(HRD) hereby accords sanction for an amount of Rs.1,01,777/- (Rupees One Lakh One Thousand Seven Hundred and Seventy Seven only) from General Ceiling to Yashoda, Hitech-City, Hyderabad. in full and final settlement of credit bills towards the medical charges mentioned in para 1 above duly deducting an amount of Rs.3000/- (Rupees Three Thousand only) towards the excess amount claimed by Yashoda, Hitech-City, Hyderabad.

The Pay Officer/TSTransco/V.S/Hyderabad is requested to arrange for payment of Rs.1,01,777/- (Rupees One Lakh One Thousand Seven Hundred and Seventy Seven only)(3Bills) from General Ceiling to M/s Yashoda Health Care Services Pvt Ltd, against their credit bills under intimation to the Chief General Manager (HRD) /TS Transco, Vidyut Soudha, Hyderabad.

An amount of Rs.97,911/- is sanctioned to Sri.N.Pavan Kumar, Artisan Gr-II, ID:No.50004551, O/o SE/OMC-Circle/Nalgonda A sum of Rs.3,866/-is recoverable from the Artisan the SE/OMC-Circle/Nalgonda is requested to recover the amount accordingly from the salary of the Artisan towards the cost of inadmissible items and intimate the same with C.B. voucher No. to the CGM(HRD)/TSTransco, within a month from the date of recovery from the salary of the Artisan concerned, failing which disciplinary action will be initiated against the concerned Disbursing Officers.
