#### ORDER:

In the reference 1st cited, orders were issued sanctioning an amount of Rs. 51,290/- (Rupees Fifty one thousand two hundred ninety) towards annual premium (including medical coverage and GST) to M/s. National Insurance Company Limited, Secunderabad for renewal of Group Personal Accident Insurance Coverage of Rs.15,00,000/- (Rupees Fifteen Lakhs) each or 72 times of the gross pay of the individual, whichever is less, for the existing 23 Nos. of (Twenty Three) Hotline Trained Staff working in Hotlines wing, TSTRANSCO for the period from 10.09.2020 to 09.09.2021.

- 2. In the 39th Board Meeting of TSTRANSCO held on 17.11.2020 it was decided to enhance risk coverage under Group Personnel Accident Insurance Policy from Rs.15 Lakhs to 50 Lakhs each to the Hotlines trained staff.
- 3. In the reference 3<sup>rd</sup> cited, the Chief Engineer/Transmission/TS Transco has requested to sanction of annual premium of Rs.1,35,812/- (including GST) (Rupees One Lakh Thirty Five thousand Eight hundred Twelve only)to M/s.The Oriental Insurance Company, Hyderabad
  - > Additional Group Personal Accident Insurance Cover of Rs.35,00,000/- each, to the existing 15 lakhs GPA Insurance each, for 20 Nos. trained Hotline staff of TSTRANSCO @ Rs.5221/- to each person for a period of one year
  - New Group Personal Accident Insurance Cover of Rs.50,00,000/- each, to the 4 Nos. newly joined trained Hotline staff of TSTRANSCO @ Rs.7848/- to each person for a period of one year.
- 4. After careful examination, the TS Transco hereby accords approval for sanction of an amount of Rs. 1,35,812/- (Rupees One Lakh Thirty Five thousand Eight hundred Twelve only) towards payment of annual premium (including GST) to M/s. The Oriental Insurance Company, Hyderabad, for Additional Group Personal Accident Insurance Coverage of Rs.35,00,000/- each to the existing GPA Insurance of Rs.15 Lakhs each for the Existing Trained Hotline Staff 20 Nos. and New Group Personal Accident Insurance Coverage of Rs.50.00 lakhs each to Newly joined 4 Nos. trained staff working in Hotlines wing, TSTRANSCO, totaling 24 Nos. (as per the enclosed Annexure) for a period of one year from date of issue of policy.

- 5. The amount sanctioned in para (4) above is subject to the Budget Provision to be made by the Chief Engineer/Transmission/VidyutSoudha, Hyderabad.
- 6. The Chief Engineer/Transmission is directed to take necessary action for payment of insurance premium sanctioned above, and get the insurance covered for the sum assured to all the employees working in Hot Lines and further requested to extend this Group Personal Accident Insurance coverage for the Hotlines trained persons joining the Hotlines wing in future.
- 7. These orders are issued with the concurrence of JMD(Fin., Comml., & HRD)vide Regd.No.668,dt.13.02.2021.
