O R D E R:

In the reference 3rd cited, the Director, Omega Hospitals, Banjara Hills, Hyderabad has preferred (1) No. credit medical bill amounting to Rs.1,23,633/- (Rupees One lakh twenty three thousand six hundred and thirty three only) towards the medical treatment extended to Smt.P.Chandrakala, W/o.P.Satyanarayana, SAO/Retd. ID.No.6501290, O/o.SE/OMC/Metro-West/Hyderabad as in-patient for the period from 20.01.2021 to 21.01.2021 for “Adeno Ca-with Low Grade Dysplasia for Chemotherapy” at Omega Hospitals, Banjara Hills, Hyderabad and requested to issue Cheque/DD in favour of Omega Hospitals.

2. After careful examination under Medical Regulations 4(f) & 9(2) of APSE Board as adopted by TSTransco and as per delegation of powers ordered in TOO.Ms.No.301, dt.31.3.2009 read with Memo dt.22-10-2020, the Chief General Manager (HRD) hereby accords sanction for an amount of Rs.1,20,633/- (Rupees One lakh twenty thousand six hundred and thirty three only) from the SFMS 2020-21 to Omega Hospitals, Banjara Hills, Hyderabad in full and final settlement of credit bill towards the medical charges mentioned in para 1 above duly deducting an amount of Rs.3,000/- (Rupees Three thousand only) towards the excess amount claimed by Omega Hospitals, Banjara Hills, Hyderabad.

3. The Pay Officer/TS Transco/VS/Hyderabad is requested to arrange for payment of Rs.1,20,633/- (Rupees One lakh twenty thousand six hundred and thirty three only) from the SFMS 2020-21 to Omega Hospitals against their credit bills under intimation to the Chief General Manager (HRD), TSTransco, Vidyut Soudha, Hyderabad

4. An amount of Rs.1,19,610/- is sanctioned to Sri P.Satyanarayana, SAO/Retd. ID.No.6501290, O/o.SE/OMC/Metro-West/Hyderabad. A sum of Rs.1,023/- is recoverable from the pensioner. The SE/OMC/Metro-West/Hyderabad is requested to recover the amount accordingly from the pension of the pensioner towards the cost of inadmissible items and intimate the same with C.B. voucher No. to the Chief General Manager (HRD), TSTransco, within a month from the date of recovery from the pension of the pensioner concerned, failing which disciplinary action will be initiated against the concerned Pay Drawing Officer.
