ORDER:

In the reference 5th cited, the Director, Yashoda, Hospitals, Hitech City, Hyderabad has preferred (1) No. credit medical bill amounting to Rs.95,603/- (Rupees Ninety Five Thousand Six Hundred and Three only) towards the medical treatment extended to Sri.R.Rangaiah, F/o.Sri.R.Veeraiah, Artisan Gr-I, ID:No.50004649, O/o SE/OMC-Circle/TSTransco/Nalgonda as in-patient from 14.10.2023 to 25.10.2023 for “Left Temporo Parieto Occipital Infract (MM)” at Yashoda, Hospitals, Hitech City, Hyderabad and requested to issue cheque in favour of “M/s Yashoda Health Care Services Pvt Ltd”.

2. After careful examination under Medical Regulations 4(f) & 9(2) of APSE Board as adopted by TS Transco, and as per delegation of powers ordered in TOO.Ms.No.301, dt.31.03.2009 read with Memo dt.22-10-2020, the CGM(HRD) hereby accords sanction for an amount of Rs.90,065/- (Rupees Ninety Thousand and Sixty Five only) for reimbursement of medical charges to Yashoda, Hospitals, Hitech City, Hyderabad in full and final settlement of credit bill towards the medical charges mentioned in para 1 above duly deducting an amount of Rs.5,538/- (Rupees Five Thousand Five Hundred and Thirty Eight only) towards the excess amount claimed by Yashoda, Hospitals, Hitech City, Hyderabad.

3. The Pay Officer/TSTransco/VS/Hyderabad is requested to arrange for payment of Rs.90,065/- (Rupees Ninety Thousand and Sixty Five only) from general ceiling to M/s Yashoda Health Care Services Pvt Ltd, against their credit bills under intimation to the Chief General Manager (HRD) /TS Transco, Vidyut Soudha, Hyderabad.

4. An amount of Rs.88,375/- is sanctioned to Sri.R.Veeraiah, Artisan Gr-I, ID:No.50004649, O/o SE/OMC-Circle/TSTransco/Nalgonda. A sum of Rs.1,690/-is recoverable from the Artisan The SE/OMC-Circle/TSTransco/Nalgonda is requested to recover the amount accordingly from the salary of the Artisan towards the cost of inadmissible items and intimate the same with C.B. voucher No. to the CGM(HRD)/TSTransco, within a month from the date of recovery from the salary of the Artisan concerned, failing which disciplinary action will be initiated against the concerned Disbursing Officers.
