ORDER:

In the reference 5th cited, the Director, Xenia Hospitals, ECIL 'X' Roads, Hyderabad has preferred (2) Nos. credit medical bills amounting to Rs.44,653/- (Rupees Forty four thousand six hundred and fifty three only) towards the medical treatment extended to Sri P.Rajender, Artisan Gr-II, ID.No.2622 O/o.SE/OMC Circlce/Metro-Central/ Hyderabad as in-patient from 16.08.2023 to 18.08.2023 & 24.08.2023 to 25.08.2023 for "SAIO, KOCH's Abdomen MM" & "Severe Pain in Lower Abdomen MM" at Xenia Hospitals, ECIL 'X' Roads, Hyderabad and requested to issue cheque in favour of Xenia Hospitals.

2. After careful examination and Medical Regulations 4(f) & 9(2) of APSE Board as adopted by TS Transco and as per delegation of powers ordered in TOO.Ms.No.301, dt.31.3.2009 and read with memo dt:22.10.2020, the Deputy Secretary (HRD) hereby accords sanction for an amount of Rs.42,853/- (Rupees Forty two thousand eight hundred and fifty three only) for reimbursement of medical charges to Xenia Hospitals, ECIL 'X' Roads, Hyderabad in full and final settlement of credit bill towards the medical charges mentioned in para 1 above duly deducting an amount of Rs.1800/- (Rupees One thousand and eight hundred only) towards the excess amount claimed by Xenia Hospitals, ECIL 'X' Roads, Hyderabad.

3. The Pay Officer/TS Transco/VS/Hyderabad is requested to arrange for payment of Rs.42,853/- (Rupees Forty two thousand eight hundred and fifty three only) (from general ceiling) to Xenia Hospitals against their credit bill under intimation to the Chief General Manager (HRD)/TS Transco, Vidyut Soudha, Hyderabad.

4. An amount of Rs.36,945/- is sanctioned to Sri P.Rajender, Artisan Gr-II, ID.No.2622 O/o.SE/OMC Circle/Metro-Central/ Hyderabad. A sum of Rs.5908/- is recoverable from the Artisan. The SE/OMC Circle/Metro-Central/Hyderabad is requested to recover amount from the salary in installments accordingly and after recovery of the total amount intimate the same with C.B.Voucher No. to the Chief General Manager (HRD)TS Transco within a month from the last date of recovery from the salary of the Artisan concerned, failing which disciplinary action will be initiated against the concerned Pay Drawing Officer/ Concerned Disbursing Officers.
