ORDER:

In the reference 4th cited, the Director, KIMS Hospitals, Minister Road, Secunderabad has preferred (1) No. credit medical bill amounting to Rs.82,692/-(Rupees Eighty Two Thousand Six Hundred and Two Only) towards the medical treatment extended to Sri.S.Ravi, LI, ID.1070148, O/o.SE/OMC/TSTransco/Nalgonda as in-patient from 17.10.2023 to 23.10.2023 for “LRTI, Post Transplantation (MM)” at KIMS Hospitals, Minister Road, Secunderabad and requested to issue a cheque in favour of “Krishna Institute of Medical Sciences Limited”.

After careful examination and Medical Regulations 4(f) & 9(2) of APSE Board as adopted by TS.Transco, as per delegation of powers ordered in TOO.Ms.No.301, dt.31.3.2009, read with memo dt:22.10.2020, the CGM(HRD) hereby accords sanction for an amount of Rs.79,840/- (Rupees Seventy Nine Thousand Eight Hundred and Forty Only) for reimbursement of medical charges to KIMS Hospitals, Minister Road, Secunderabad in full and final settlement of credit bills towards the medical charges mentioned in para 1 above duly deducting an amount of Rs.2,852/- (Rupees Two Thousand Eight Hundred and Fifty Two only) towards the excess amount claimed by KIMS Hospitals, Minister Road, Secunderabad.

3. The Pay Officer/TSTransco/VS/Hyderabad is requested to arrange for payment of Rs.79,840/- (Rupees Seventy Nine Thousand Eight Hundred and Forty Only) from general ceiling to Krishna Institute of Medical Sciences Limited, against their credit bills under intimation to the Chief General Manager (HRD)/TS Transco, Vidyut Soudha, Hyderabad.

4. An amount of Rs.79,446/- is sanctioned to Sri.S.Ravi, LI, ID.1070148, O/o.SE/OMC/TSTransco/Nalgonda. A sum of Rs.394/-is recoverable from the employee. The SE/ OMC/TSTransco/Nalgonda is requested to recover the amount accordingly from the salary of the employee towards the cost of inadmissible items and intimate the same with C.B. voucher No. to the Chief General Manager (HRD)/TSTransco, within a month from the date of recovery from the salary of the employee concerned, failing which disciplinary action will be initiated against the concerned Pay Drawing Officer
