ORDER:

Under Regulation-14(a)(1) of TSTRANSCO Service Regulations Part-II, Sri V. Haranadha Babu, SAO is promoted as Dy.CCA with effect from the date of assumption of charge.

If, he fails to join or evade joining within stipulated period or proceeding on leave from the date of receipt of this order, his right for promotion shall be forfeited for the current panel year and the names of such candidates shall be placed before the next DPC for consideration in the next panel year, subject to availability of vacancy.

The promotions ordered in Para-1 above is subject to review as per the Clarification dtd.29.05.2021 issued by the Government of Telangana with regard to fixation of seniority based on "merit ranking"; and also in terms of the Circular Memo dtd.24-10-2019 issued by the Scheduled Castes Development Department, Government of Telangana on the implementation of the rule of reservation to SCs/STs in promotions conferring "consequential seniority" or otherwise and implementation of "catch-up rule".
