ORDER:

Whereas, in the reference 2nd read above, under Reg.14(a)(1) of TSTRANSCO SRs Part-II, the following **10** Superintending Engineers/Electrical were promoted temporarily as Chief Engineers/Electrical for the panel drawn on 01.05.2017 & 09.06.2017 keeping in view the exigencies of work and to suit administrative convenience:

2. The promotions ordered above were subject to the following conditions:
 - i. The promotions are temporary and liable for termination at anytime without notice and without assigning any reasons therefor
 - ii. The promotions are subject to outcome of the Judgment in WP No.16660/2015 & Batch of the Hon'ble High Court, which is the subject matter of CA. No.11435/2018 & Batch in the Hon'ble Supreme Court; and also subject to outcome of Contempt Case (C) D.No.28852/2020 in MA No.1270/2020 in CA No.11435/2018 & Batch.

- iii. The promotions are subject to the finalization of allocation of employees between APTRANSCO & TSTRANSCO and subsequent change in the seniority, if any.
- iv. The promotions shall be reviewed after completion of the process of final allocation of cadre strength, vacancies and employees between successor States by the Government and persons so promoted meanwhile shall not have any right on such promotions.

3. Whereas, as per the Judgments of the Hon'ble Supreme Court in the references 5th, 6th and 7th read above, the allocation of employees between APTRANSCO & TSTRANSCO has attained finality. As such, in the reference 8th read above, the "inter-se-seniority" of the Petitioners vis-à-vis the employees working in TSTRANSCO as on 02-06-2014 has been fixed and drawn. Consequently, the previous seniority of SE/Elec., has undergone significant change, necessitating review of the panels drawn earlier based on the said seniority. As a result, the promotions ordered from the earlier panel dtd.01.05.2017 & 09.06.2017 for promotion of SEs/Elecl., as CEs/Elecl., shall also be required to be re-drawn.

3. Therefore, the earlier panel dtd.01.05.2017 & 09.06.2017 drawn for promotion of SEs/Elecl., as CEs/Elecl., has been re-drawn taking into consideration the "Inter-se-Seniority" now fixed as on 02-06-2014.

4. After careful consideration, the TSTRANSCO has decided to cancel the promotions ordered in the reference 2nd read above, since the said promotions ordered therein were subject to the conditions as extracted at Para-2 above. Accordingly, the promotions ordered in respect of the following SEs/Elecl., as CEs/Elecl are hereby cancelled with immediate effect:
