### ORDER:

Under Regulation-14(a)(1) of TSTRANSCO Service Regulations Part-II, Sri C. Ram Prasad, Superintending Engineer (Telecom) is promoted as Chief Engineer (Telecom) with effect from the date of assumption of charge.

2. The above Superintending Engineer on his promotion as Chief Engineer (Telecom) as ordered in Para-1 above is transferred and posted to the place noted against his name in the Annexure appended to this order.

3. The Superintending Engineer (Telecom) is requested to assume charge on his promotion as Chief Engineer (Telecom) at the place of posting indicated against his name, within 15 days from the date of issue of the orders. If, he fails to join or evade joining within stipulated period or proceeding on leave from the date of receipt of this order, his right for promotion shall be forfeited for the current panel year and the name of such candidate shall be placed before the next DPC for consideration in the next panel year, subject to availability of vacancy.

4. The promotion ordered in Para-1 above is subject to review as per the Clarification dtd.29.05.2021 issued by the Government of Telangana with regard to fixation of seniority based on "merit ranking"; and also in terms of the Circular Memo dtd.24-10-2019 issued by the Scheduled Castes Development Department, Government of Telangana on the implementation of the rule of reservation to SCs/STs in promotions conferring "consequential seniority" or otherwise and implementation of "catch-up rule".
