**ORDER:**

In the reference 3<sup>rd</sup> cited, the Director, Care Hospital, Banjara Hills, Hyderabad has preferred (1) No. credit medical bill amounting to Rs.1,30,113/- (Rupees One lakh thirty thousand one hundred and thirteen only) towards the medical treatment extended to Sri Shaik Raza Ahmed, LI(Retd.), ID.No.6501509, O/o.SE/OMC Circle/Metro-Central/ Hyderabad as in-patient for the period from 25.10.2020 to 29.10.2020, 09.11.2020, 04.12.2020 & 24.12.2020 to 29.12.2020 for “UGI Endoscopy with Biopsy MM & Ca.Stomach” and requested to issue cheque in favour of Quality Care India Limited.

2. After careful examination and as per Medical Regulations 4(f) &9(2) of A.P.S.E.Board as adopted by TSTransco, the Deputy Secretary (HRD) as per delegation of powers orders in T.O.O.Ms.No.301, dt.31.3.2009, read with Memo dt.22-10-2020, the hereby accords sanction for an amount of Rs.1,27,863/- (Rupees One lakh twenty seven thousand eight hundred and sixty three only) to Care Hospital, Banjara Hills, Hyderabad in full and final settlement of credit bill towards the medical charges mentioned in para 1 above duly deducting an amount of Rs.2,250/- (Rupees Two thousand two hundred and fifty only) towards the excess amount claimed by Care Hospital, Banjara Hills, Hyderabad.

3. The Pay Officer/TS Transco/VS/Hyderabad is requested to arrange for payment of Rs.1,27,863/- (Rupees One lakh twenty seven thousand eight hundred and sixty three only) to Quality Care India Limited against their credit bill under intimation to the Chief General Manager (HRD), Vidyut Soudha, Hyderabad.

4. An amount of Rs.1,18,618/- is sanctioned to Sri Shaik Raza Ahmed, LI(Retd.), ID.No.6501509, O/o.SE/OMC Circle/Metro-Central/ Hyderabad. A sum of Rs.9,245/- is recoverable from the pensioner. The SE/OMC Circle/Metro-Central/Hyderabad is requested to recover the amount accordingly in instalments from the pension of the pensioner towards the cost of inadmissible items and intimate the same with C.B. voucher No. to the Chief General Manager (HRD)TS Transco, within a month from the date of recovery from the pension of the pensioner concerned, failing which disciplinary action will be initiated against the concerned Pay Drawing Officer.
