**ORDER:**

In the reference 3<sup>rd</sup> cited, the Director, Yashoda Hospitals, Malakpet, Hyderabad has preferred (1) No. credit medical bill amounting to Rs.86,912/- (Rupees Eighty Six Thousand Nine Hundred and Twelve only) towards the medical treatment extended to Smt. M.Nagakumari, W/o. Late M.R.K.Sarma, AAO/Retd ID No.6600492 O/o. Pay Officer/TSTransco/VS/Hyderabad for “Acute Febrile Illness Pneumonia HTN Hypothy (MM)” from 11-8-2022 to 13-8-2022 at Yashoda Hospitals, Malakpet, Hyderabad and requested to issue cheque in favour of Yashoda Health Care Services Pvt. Ltd.

2. After careful examination under Medical Regulations 4(f) & 9(2) of APSE Board as adopted by TS Transco and as per delegation of powers ordered in TOO.Ms.No.301, dt.31.3.2009 read with Memo dt. 22-10-2020, the Chief General Manager (HRD) hereby accords sanction for an amount of Rs.86,911/- (Rupees Eighty Six Thousand Nine Hundred and Eleven only) from General Ceiling to Yashoda Hospitals, Malakpet, Hyderabad in full and final settlement of credit bills towards the medical charges mentioned in para 1 above duly deducting an amount of Rs.1/- (Rupees One only) towards the excess amount claimed by Yashoda Hospitals, Malakpet, Hyderabad.

3. The Pay Officer/TS Transco/VS/Hyderabad is requested to arrange for payment of Rs.86,911/- (Rupees Eighty Six Thousand Nine Hundred and Eleven only) from General Ceiling to Yashoda Health Care Services Pvt. Ltd. against their credit bills under intimation to the Chief General Manager (HRD)/TS Transco, Vidyut Soudha, Hyderabad.

4. An amount of Rs.83,139/- is sanctioned to Smt. M.Nagakumari, W/o. Late M.R.K.Sarma, AAO/Retd ID No.6600492 O/o. Pay Officer/TSTransco/VS/Hyderabad. A sum of Rs.3,772/- is recoverable from the Pensioner. The Pay Officer/VS/Hyderabad is requested to recover the amount accordingly in instalments from the pension of the Pensioner towards the cost of inadmissible items and intimate the same with C.B. voucher No. to the Chief General Manager (HRD)/TSTransco, within a month from the date of recovery from the pension of the Pensioner concerned, failing which disciplinary action will be initiated against the concerned Pay Drawing Officer.
