ORDER:

In the reference 3<sup>rd</sup> cited, the Director, Yashoda Hospitals, Secunderabad has preferred (1) No. credit medical bill amounting to Rs.48,996/- (Rupees Forty eight thousand nine hundred and ninety six only) towards the medical treatment extended to Smt M.Vanitha, OS ID.No.1072628 O/o.SE/ OMC / Sangareddy as in-patient for the period from 22-06-2018 to 27.06.2018 for “Acute Febrile Illness, Left Hemiparesis, CAD-USA, HTN, DM, Hypothroidism, Anemia (Medical Management)” at Yashoda Hospitals, Secunderabad.

2. After careful examination and Medical Regulations 4(f) & 9(2) of APSE Board as adopted by TS.Transco, the Chief General Manager (HRD) as per delegation of powers ordered in TOO.Ms.No.301, dt.31.3.2009, read with memo dt:1.10.2009, Memo dt. 28-7-2014 hereby accords sanction for an amount of Rs.35,183/- (Rupees Thirty five thousand one hundred and eighty three only) for reimbursement of medical charges to Yashoda Hospitals, Secunderabad in full and final settlement of credit bills towards the medical charges mentioned in para 1 above duly deducting an amount of Rs.13,813/- (Rupees Thirteen thousand eight hundred and thirteen only) towards the excess amount claimed by Yashoda Hospitals, Secunderabad.

3. The Pay Officer/TS Transco/VS/Hyderabad is requested to arrange for payment of Rs.35,183/- (Rupees Thirty five thousand one hundred and eighty three only) to Yashoda Hospitals, Secunderabad against their credit bills under intimation to the Chief General Manager (HRD)/TS Transco, Vidyut Soudha, Hyderabad.

4. An amount of Rs.34,686/- is sanctioned to Smt M.Vanitha, OS ID.No.1072628 O/o.SE/ OMC / Sangareddy. A sum of Rs.497/- is recoverable from the employee. The SE/OMC/Sangareddy is requested to recover the amount accordingly from the first salary of the employee towards the cost of inadmissible items and intimate the same with C.B. voucher No. to the CGM (HRD)/TS Transco, within a month from the date of recovery from the first salary of the employee concerned, failing which disciplinary action will be initiated against the concerned Pay Drawing Officer.
