The Pay Officer/TS Transco/VS/Hyderabad is requested to arrange for payment of Rs. 55,949/- (Rupees Fifty five thousand nine hundred and forty nine only) to Quality Care India Limited against their credit bill under intimation to the Chief General Manager (HRD)/TS Transco, Vidyt Soudha, Hyderabad.
