- After careful examination and Medical Regulations 4(f) & 9(2) of APSE Board as adopted by TSTransco, Chief General Manager (HRD)/TSTransco as per delegation of powers ordered in TOO.Ms.No.301, dt.31.3.2009, read with memo 22.10.2020 the hereby accords sanction for an amount of Rs.53,435/- (Rupees Fifty three thousand four hundred and thirty five only) to Yashoda Hospital, Somajiguda, Hyderabad in full and final settlement of credit bill towards the medical charges mentioned in para 1 above duly deducting an amount of Rs.302/- (Rupees Three hundred and two only) towards the excess amount claimed by Yashoda Hospital, Somajiguda, Hyderabad.
- The Pay Officer/TS Transco/VS/Hyderabad is requested to arrange for payment of Rs.53,435/-(Rupees Fifty three thousand four hundred and thirty five only) under general ceiling to M/s. Yashoda Super Speciality Hospital against their credit bill under intimation to the Chief General Manager (HRD)/ TSTransco, Vidyut Soudha, Hyderabad.
- An amount of Rs.51,736/- is sanctioned to Sri. B.Anjaiah, ALM (Retd.), ID.No.6501536, O/o.SE/OMC/Metro-Central/Hyderabad. A sum of Rs.1699/- is recoverable from the pensioner. The SE/OMC/Metro-Central/Hyderabad is requested to recover the amount accordingly in installments from the salary of the pensioner towards the cost of inadmissible items and intimate the same with C.B. voucher No. to the Chief General Manager (HRD) within a month from the date of recovery from the salary of the pensioner concerned, failing which disciplinary action will be initiated against the concerned Pay Drawing Officer.
