ORDER:

In the reference 4th cited, the Director, Yashoda Hospitals, Malakpet, Hyderabad has preferred (1) No. credit medical bill amounting to Rs.61,348/- (Rupees Sixty one thousand three hundred and forty eight Only) towards the medical treatment extended to Sri D.Nagaiah, F/o Sri. D.Suresh, Artisan Grade-II, ID.No.50004928, O/o.SE/OMC/Metro-East/Hyderabad for “Rt Lower Limb Cellulites, DM-HTN, (MM)” from 07.06.2023 to 12.06.2023 at Yashoda Hospitals, Malakpet, Hyderabad and requested to issue a cheque in favour of M/s.Yashoda Health Care Services Pvt. Ltd.

2. After careful examination and Medical Regulations 4(f) & 9(2) of APSE Board as adopted by TSTransco, Chief General Manager (HRD)/TSTransco as per delegation of powers ordered in TOO.Ms.No.301, dt.31.3.2009, read with memo 22.10.2020 hereby accords sanction for an amount of Rs.60,998/- (Rupees Sixty thousand nine hundred and ninety eight only) to Yashoda Hospital, Malakpet, Hyderabad in full and final settlement of credit bill towards the medical charges mentioned in para 1 above duly deducting an amount of Rs.350/- (Rupee Three hundred and fifty only) towards the excess amount claimed by Yashoda Hospital, Malakpet, Hyderabad.

3. The Pay Officer/TS Transco/VS/Hyderabad is requested to arrange for payment of Rs.60,998/- (Rupees Sixty thousand nine hundred and ninety eight only) from the SFMS 2023-24 to M/s.Yashoda Health Care Services Pvt. Ltd against their credit bill under intimation to the Chief General Manager (HRD)/TSTransco, Vidyut Soudha, Hyderabad.

4. An amount of Rs.59,398/- is sanctioned to Sri. D.Suresh, Artisan Grade-II, ID.No.50004928, O/o.SE/OMC/Metro-East/Hyderabad. A sum of Rs.1,600/- is recoverable from the Artisan. The SE/OMC/Metro-East/Hyderabad is requested to recover the amount accordingly in installments from the salary of the Artisan towards the cost of inadmissible items and intimate the same with C.B. voucher No. to the Chief General Manager (HRD) within a month from the date of recovery from the salary of the Artisan concerned, failing which disciplinary action will be initiated against the concerned Pay Drawing Officer.
