ORDER:

In the reference 3<sup>rd</sup> cited, the Director, Medicover Hospital (A unit of Sahrudaya Healthcare Pvt. Ltd.) Secretariat Road, Hyderabad has preferred (1) No. credit medical bill amounting to Rs.47,252/- (Rupees Forty seven thousand two hundred and fifty two only) towards the medical treatment extended to Smt D.Laxmi M/o Sri D.Nagaraju, Artisan Gr-II ID.No.0687 O/o. SE/OMC/Metro-East/Hyderabad as in-patient from 08-08-2019 to 13.08.2019 for “Acute CVA Hemipresis (Medical Management)” at Medicover Hospital (A unit of Sahrudaya Healthcare Pvt. Ltd.) Secretariat Road, Hyderabad and requested to issue cheque in the favour of Sahrudaya Health Care Private Limited.

2. After careful examination and Medical Regulations 4(f) & 9(2) of APSE Board as adopted by TS.Transco, the Chief General Manager (HRD) as per delegation of powers ordered in TOO.Ms.No.301, dt.31.3.2009, read with memo dt:1.10.2009, Memo dt.28-7-2014 here by accords sanction for an amount of Rs.47,191/- (Rupees Forty seven thousand one hundred and ninety one only) for reimbursement of medical charges to Medicover Hospital (A unit of Sahrudaya Healthcare Pvt. Ltd.) Secretariat Road, Hyderabad in full and final settlement of credit bills towards the medical charges mentioned in para 1 above duly deducting an amount of Rs.61/- (Rupees Sixty one only) towards the excess amount claimed by Medicover Hospital (A unit of Sahrudaya Healthcare Pvt. Ltd.) Secretariat Road, Hyderabad.

The Pay Officer/TS Transco/VS/Hyderabad is requested to arrange for payment of Rs.47,191/- (Rupees Forty seven thousand one hundred and ninety one only) to Sahrudaya Health Care Private Limited against their credit bills under intimation to the Chief General Manager (HRD)/TS Transco, Vidyut Soudha, Hyderabad.

4. An amount of Rs.46,370/- is sanctioned to Sri D. Nagaraju, Artisan Gr-II ID.No.0687 O/o.SE/OMC/Metro-East/Hyderabad. A sum of Rs.821/- is recoverable from the artisan. The SE/OMC/Metro-East/Hyderabad is requested to recover amount from the salary in installments accordingly and after recovery of the total amount intimate the same with C.B.Voucher No. to the Chief General Manager (HRD)/TS Transco within a month from the last date of recovery from the salary of the artisan concerned, failing which disciplinary action will be initiated against the concerned Pay Drawing Officer/Concerned Disbursing Officers.
