The Pay Officer/TS Transco/VS/Hyderabad is requested to arrange for payment of Rs.50,286/- (Rupees Fifty thousand two hundred and eighty six only) to Apollo Reach Hospitals, Karimnagar against their credit bills under intimation to the Chief General Manager (HRD)/TS Transco, Vidyut Soudha, Hyderabad.
