ORDER:

In the reference 4<sup>th</sup> cited, the Director, Yashoda Hospitals, Secunderabad has preferred (1) No. credit medical bill amounting to Rs.76,796/- (Rupees Seventy Six Thousand Seven Hundred and Ninety Six only) towards the medical treatment extended to Smt. S.Krishnaveni, M/o. Sri S.Vijay Kumar, Artisan, Grade-III, ID.No.50002584, O/o. SE/OMC/Metro-Central/Hyderabad as in-patient for the period from 21-04-2023 to 26-04-2023 for “Severe OAKnee, CAD, HTN, Anemia (MM)” at Yashoda Hospitals, Secunderabad and requested to issue cheque in favour of M/s. Yashoda Health Care Services Pvt. Ltd.

2. After careful examination under Medical Regulations 4(f) & 9(2) of APSE Board as adopted by TS Transco and as per delegation of powers ordered in TOO.Ms.No.301, dt.31.3.2009 read with Memo dt. 22-10-2020, the Chief General Manager (HRD) hereby accords sanction for an amount of Rs.76,295/- (Rupees Seventy Six Thousand Two Hundred and Ninety Five only) from SFMS 2022-23 to Yashoda Hospitals, Secunderabad in full and final settlement of credit bill towards the medical charges mentioned in para 1 above duly deducting an amount of Rs.501/- (Rupees Five Hundred One only) towards the excess amount claimed by Yashoda Hospitals, Secunderabad.

3. The Pay Officer/TS Transco/VS/Hyderabad is requested to arrange for payment of Rs.76,295/- (Rupees Seventy Six Thousand Two Hundred and Ninety Five only) from SFMS 2022-23 to M/s. Yashoda Health Care Services Pvt. Ltd. against their credit bill under intimation to the Chief General Manager (HRD)/TS Transco, Vidyut Soudha, Hyderabad.

4. An amount of Rs72,771/- is sanctioned to Sri S.Vijay Kumar, Artisan, Grade-III, ID.No.50002584 O/o. SE/OMC/Metro-Central/Hyderabad. A sum of Rs.3,524/- is recoverable from the Artisan. The SE/OMC/Metro-Central/Hyderabad is requested to recover amount from the salary in installments accordingly and after recovery of the total amount intimate the same with C.B. voucher No. to the Chief General Manager (HRD)TS Transco, within a month from the last date of recovery from the salary of the Artisan concerned, failing which disciplinary action will be initiated against the concerned Pay Drawing Officer/ Concerned Disbursing Officers.
