After careful examination and Medical Regulations 4(f) & 9(2) of APSE Board as adopted by TS.Transco, the Deputy Secretary (HRD) as per delegation of powers ordered in TOO.Ms.No.301, dt.31.3.2009, read with memo dt:22.10.2020 hereby accords sanction for an amount of Rs.20,500/- (Rupees Twenty thousand and five hundred only) for reimbursement of medical charges to Yashoda Hospitals (Yashoda Health Care Services Pvt., Ltd.), Secunderabad in full and final settlement of credit bill towards the medical charges mentioned in para 1 above duly deducting an amount of Rs.525/- (Rupees Five hundred and twenty five only) towards the excess amount claimed by Yashoda Hospitals (Yashoda Health Care Services Pvt., Ltd.), Secunderabad.
