**ORDERS :**

In the reference 1<sup>st</sup> cited, orders were issued sanctioning an amount of Rs.49,060/- (Rupees Forty Nine thousand Sixty only) towards annual premium (including medical coverage and service tax @ Rs.12.36%) to M/s.National Insurance Company Limited, Secunderabad for renewal of Group Personal Accident Insurance Coverage of Rs.15,00,000/- (Rupees Fifteen Lakhs) each or 72 times of the gross pay of the individual, whichever is less, for the existing 22 Nos. of (Twenty two) Hotline Trained Staff working in Hotlines wing, TSTRANSCO for the period from 10.09.2017 to 09.09.2018.

2. In the reference 2<sup>nd</sup> cited, the Chief Engineer (Transmission) TS Transco has stated that, the existing Group Personal Accident Insurance Coverage with M/s. National Insurance Company Limited, Secunderabad, referred to at para (1) is going to expire by 09.09.2018 and requested for payment of annual premium of Rs.49,060/- (including medical coverage and service tax @ Rs.14.42%) (@ Rs.2,230/- to each staff) for renewal of Group Personal Accident Insurance Coverage of Rs.15,00,000/- each (or) 72 times of the gross pay of the individual, whichever is less, to the 22 nos. trained Hotline staff of TS Transco, for a further period of one year from 10.09.2018 to 09.09.2019.

3. After careful examination of the proposal of the Chief Engineer (Transmission) TSTRANSCO, Vidyut Soudha, Hyderabad, TS Transco hereby accords approval for sanction of an amount of Rs.49,060/- (Rupees Forty Nine thousand Sixty only) towards payment of annual premium (including medical coverage and GST) to M/s. National Insurance Company Limited, Secunderabad, [Rs.2,230/-for each person] for renewal of Group Personal Accident Insurance Coverage of Rs.15,00,000/- each (or) 72 times of the gross pay of the individual, whichever is less, to the (22 Nos). trained staff working in Hotlines wing of TS Transco, (as per the enclosed Annexure) for a further period of one year from 10.09.2018 to 09.09.2019.

4. The amount sanctioned in para(3) above is subject to the Budget Provision to be made by the Chief Engineer/Transmission/Vidyut Soudha, Hyderabad.

5. The Chief Engineer/Transmission is requested to take necessary action for payment of insurance premium sanctioned above, and get the insurance covered for the sum assured to all the employees working in Hot Lines and further requested to extend this Group Personal Accident Insurance coverage for the Hotlines trained persons joining the Hotlines wing in future.
