ORDER:

The CMD/TSNPDCL vide reference 3rd cited has informed that, consequent on creation of new circles co-terminus with the Revenue Districts, 100 No's additional ADE posts sanctioned by the Government of Telangana were allotted to various field positions and to various wings in Operation Circles. However, the said posts are not adequate in all the Circles and there is shortage of ADE posts in field, DPE & MRT wings of TSNPDCL. Further, the seniority of the AEs has been revised as per the Merit-Cum-Seniority, due to which certain AEs who were earlier in the zone of consideration, were not considered for promotion to the post of ADE. In order to consider them for promotion, 23 ADE posts are required.

Stating the above, the CMD/TSNPDCL has requested to divert 23 No's ADE/Elecl., posts from TSTRANSCO to TSNPDCL to consider promotion for existing AEs in the revised seniority list.

2. After careful examination, TSTRANSCO hereby accords approval for temporary diversion of 23 No's ADE/Elecl., posts from newly sanctioned posts in TSTRANSCO by the Government vide reference 1st cited, to TSNPDCL on returnable basis.
