The scope of the work assigned are as here under:-

1.Assistance in drafting letters and follow up with relevant authorities and the officials of TS TRANSCO :-

- A letter addressing to the Chief Secretary I&CAD Department regarding the issue that the amounts are not received from I&CAD and thereby not treated as Grants along with the implications on the State Government;
- A letter addressing to KIPCL and TSWRIDC not to deduct TDS on the contributions received from KIPCL/TSWRIDC on behalf of I&CAD department, Government of Telangana since LIS projects are meant for providing water to meet Ayacut needs of the en-route canals, tanks etc., in the public interest, these specified tagged contributions received for specific purpose are treated as Capital Grants but not as income/sales to TSTRANSCO;
- A letter addressing to Special Chief Secretary, Revenue Department, Government of Telangana regarding the above issues for placing before the GST Council for extending the exemption applicable to DISCOMs for works undertaken in relation to irrigation to be applicable to Transmission Utility (TS TRANSCO) as well;
- Collation of facts, follow up with the relevant authorities and the officials of TS TRANSCO with regard to the above mentioned matters and bring them to a finality.

2.Personal representation of the TSTRANSCO before the DGGI :-

Our assistance to the TSTRANSCO in this aspect would include but not limited to:

- Assisting in drafting letters to DGGI or review of any other communication with DGGI.
- Assisting TS TRANSCO by way of representation before the DGGI during investigation, summons etc.
