In the reference (1) cited, the CE/IT&QC & SE/SLDC were nominated as Chief Information Security Officer(CISO) & Alternate CISO, respectively for TSTRANSCO.

- 2) The CERC issued “Communication System for Inter-State Transmission of Electricity Regulation 2017” which came into force w.e.f.01.07.2017.These Regulations stipulated the roles of SLDC,STU etc. along with Cyber security aspects to address network security needs.
- 3) The Cyber security aspects are comprising of Communication in Transmission system, SCADA & IT systems and applications.
- 4) To enable compliance as per CERC regulations and operationalize Cyber security guidelines, a Team with the Officers as mentioned below has been formed:

- 5) The above Team shall carryout the following activities:
 - (a) Shall report and assist CISO & Alternate CISO.
 - (b) Shall compile the data of IT infrastructure (Data center, Systems, Backup Solutions, Communication equipment etc.) of both IT & SLDC wings which required to be audited.
 - (c) Shall compile the data of software and application (OS, Databases, Websites, Programs etc.) of both IT & SLDC wings which required to be audited.

- (d) Shall coordinate with SRPC, Power grid and other agencies for auditing as per Cyber Security compliance.
- (e) Shall apprise CISO & Alternate CISO on meetings, guidelines, instructions etc. issued by concerned authorities on Cyber security from time to time without fail.
- (f) Shall comply to the instructions/ suggestions issued by CISO & Alternate CISO from time to time.
