ORDER :

In the references 1st & 2nd cited, orders were issued appointing Sri.C.Mohan Chander, retired Dy.CCA as Officer on Special Duty / TSPCC to discharge the duties and responsibilities of Dy.CCA / TSPCC for a period of one year w.e.f. 01-08-2018, i.e., upto 31.07.2019, with a remuneration of Last Pay Drawn minus pension limited to Rs.1,00,000/- (Rupees One Lakh only) per month. It was also ordered therein that the remuneration will be shared in equal ratio by TSTRANSCO / TSDISCOMS.

2. Further, all the bifurcation related issues with A.P. are still pending including the NCLT case filed by APGENCO. Sri.C.Mohan Chander is also co-ordinating with various funding agencies for short and medium term loans, including opening of LC as per the latest letter from MOP. He is also responsible for pursuing release of subsidy and other dues receivable from the Government.

Taking into consideration of the above position and after careful examination of the matter, the services of Sri.C.Mohan Chander, Dy.CCA(OSD)/TSPCC, are herewith extended as Officer on Special Duty / TSPCC to discharge the duties and responsibilities of Dy.CCA / TSPCC for a further period of one year from 01-08-2019 with same terms and conditions.

4. TSTRANSCO reserves the right to cancel/delete or alter any of the terms and conditions of the said appointment.
