# ORDER:

Under Regulation 14 (a) (1) of APSEB Service Regulations Part-II, as adopted by TSTRANSCO, the following **4 Assistant Engineers (Telecom)** mentioned in the Annexure appended to this order are promoted temporarily to act as Assistant Divisional Engineers / Telecom with effect from the date of assumption of charge.

- 2. The promotions ordered in para-1 are in the ratio of 1:3:1 as per Note-1 of Reg.6 (b) of APSEBoard S.Rs.—Part-III as adopted by TSTRANSCO.
- 3. The promotions ordered above are also as per the Rule of Reservation in promotion in favour of SCs, STs & PH as adopted by TSTRANSCO.
- 4. The promotions ordered in para-1 above are purely temporary and liable for review/cancellation at any time without notice and without assigning any reasons thereto.
- 5. The promotions ordered in para-1 above are subject to outcome of the WP.No.11588/2014 & WP No.39282 of 2015 and others pending in the Hon'ble High Court of Judicature at Hyderabad for the State of Telangana.
- 6. The promotions ordered in para-1 above are subject to outcome of contempt case vide Diary No.28852/2020 pending before the Hon'ble Supreme Court of India.
- 7. They are informed that their seniority in the cadre of ADE will be fixed at a later date after review and re-fixing their seniority in accordance with the existing regulations after outcome of pending court cases.
- 8. The promotees are directed to assume charge on promotion as Asst.Divisional Engineer/Telecom at the place of posting ordered after obtaining proper relief from the present place of working.
- 9. The concerned Controlling Officers are requested to relieve the above promotees by making local arrangements pending posting of substitutes to enable them to assume charge on promotion as Assistant Divisional Engineers/Telecom at the place of posting ordered.

10. The promotees are informed that any request for change of posting will not be entertained and they shall assume charge accordingly, after obtaining proper relief within 15 days from the date of receipt of these orders, failing which, they have to forego all the rights both at present and in future for such higher posts. If they fail to join duty within the time limit or evade to join duty, such period till they re-join, will be treated as unauthorized absence, besides treating such period of unauthorized absence as "DIES-NON" and they shall also be liable for disciplinary action.
