ORDER:

Smt.Byru Shilpa, AE/Elecl., O/o.SE/OMC/Khammam/TSTransco is hereby placed on deputation to GHMC, initially for a period of one year from the date of her relief from TSTRANSCO on usual terms and conditions of deputation, at her request.

2. The deputation ordered above is subject to the following conditions, as per the existing regulations:

- Leave Salary & Gratuity contributions due for the period of Foreign Service shall be paid by the employee herself, unless the Foreign Employer consents to pay them at the rates as prescribed by TSTRANSCO from time to time. (i.e., if GHMC fails to pay the LS & GC, Smt.B.Shilpa, AE has to pay the same to TSTransco)
- The foreign employer/employee shall remit Leave salary and Gratuity contributions within fifteen days from the end of the month in which the pay on which it is based has been drawn by the employee concerned.
- The foreign employer/employee shall pay the contribution for the period of foreign service but also for the period of leave earned by the employee in foreign service.
- Delay in remittance will cause the penal interest at the rate of 2 Np. Per day per Rs.100 upon the amount due from the date of expiry of the said period to the date on which the contribution is finally paid.

3. The Superintending Engineer/OMC/Khammam is directed to relieve the above said incumbent forthwith.

4. Smt.Byru Shilpa, AE/Elecl. is directed to report to the Executive Engineer (Electrical)/Charminar Zone/GHMC after obtaining proper relief from the present place of working in TSTRANSCO.

5. After expiry of the deputation period, Smt.Byru Shilpa, AE/Elecl. shall report to CGM(HRD)/TSTRANSCO well in advance for issue of reposting orders without fail. If she fails to report, suitable disciplinary action will be initiated against her for non-compliance of the orders.
