**ORDER:**

In the reference 1<sup>st</sup> cited orders were issued for utilizing the services of Sri.G.Ashok Kumar, Superintendent of Police (Non-Cadre) (Retired) on contract basis as Chief Vigilance Officer, TS Transco, Hyderabad for a period of one year from the date of issue of said orders i.e., 03.07.2019.

The post of SP/ASP sanctioned for TS Transco in Vigilance Wing is vacant and no in-service officer is posted by the Government of Telangana State.

It is essential to continue the services of Sri.G.Ashok Kumar for a period of one more year or till an in-service officer is posted in his place, to resolve the issues related to ROW, Vigilance enquiries and co-ordination with Distribution Companies for APTS Police Stations etc.

After careful consideration, it is hereby ordered that the services of Sri.G.Ashok Kumar, Superintendent of Police (Non-Cadre) (Retired) shall be continued as Chief Vigilance Officer, TS Transco on contract basis for period of one more year from the date of expiry of his present contract period w.e.f. 03.07.2020 AN, duly fixing the monthly remuneration of Rs.100,000/- (One Lakh only). He shall discharge the functions of TS TRANSCO Vigilance including coordination with Chief Vigilance Officer of Distribution companies.

He shall report to Joint Managing Director (Fin., Comml., HRD & Vig.)/ TS Transco/Vidyut Soudha/Hyderabad.
