In the references 11th & 12th cited, the Secretary to Govt. of Telangana informed that, every department should constitute ICC as per section 4 (1) Sexual Harassment of women at workplace (Prevention, Prohibition and Redressal) Act, 2013 by taking every department as a unit and requested to constitute ICC as per provision stipulated under section 4(1) of the act and also requested to direct all the HODs under administration control of their departments for constituting ICCs treating every department as a unit.
- 3. After careful examination, TSTRANSCO hereby re-constitutes the "Internal complaints committee" with the following members.
