ORDER:

In the reference 3rd cited, the Director, Yashoda Hospital, Malakpet, Hyderabad has preferred (1) No. credit medical bill amounting to Rs.68,897/- (Rupees Sixty eight thousand eight hundred and ninety seven only) towards the medical treatment extended to Smt.Zulekha Bee, W/o.Late MD.Khaja Miya, Jr.Asst/Retd. ID.No.6600813, O/o.SE/OMC/Metro-West/Hyderabad as in-patient for the period from 26.10.2020 to 30.10.2020 for “Sigmoidoscopy, Acute GE with Haemorrhoids (MM)” at Yashoda Hospital, Malakpet, Hyderabad and requested to issue Cheque/DD in favour of M/s.Yashoda Health Care Services Private Limited.

After careful examination under Medical Regulations 4(f) & 9(2) of APSE Board as adopted by TSTransco and as per delegation of powers ordered in TOO.Ms.No.301, dt.31.3.2009 read with Memo dt.22-10-2020, the Chief General Manager (HRD) hereby accords sanction for an amount of Rs.68,897/- (Rupees Sixty eight thousand eight hundred and ninety seven only) to Yashoda Hospital, Malakpet, Hyderabad in full and final settlement of credit bills towards the medical charges.

3. The Pay Officer/TS Transco/VS/Hyderabad is requested to arrange for payment of Rs.68,897/- (Rupees Sixty eight thousand eight hundred and ninety seven only) to M/s.Yashoda Health Care Services Private Limited against their credit bills under intimation to the Chief General Manager (HRD), TSTransco, Vidyut Soudha, Hyderabad

4. An amount of Rs.66,373/- is sanctioned to Smt.Zulekha Bee, W/o.Late MD.Khaja Miya, Jr.Asst/Retd. ID.No.6600813, O/o.SE/OMC/Metro-West/Hyderabad. A sum of Rs.2,524/- is recoverable from the pensioner. The Pay Officer/VS/Hyderabad is requested to recover the amount accordingly in instalments from the pension of the pensioner towards the cost of inadmissible items and intimate the same with C.B. voucher No. to the Chief General Manager (HRD)TS Transco, within a month from the date of recovery from the pension of the pensioner concerned, failing which disciplinary action will be initiated against the concerned Pay Drawing Officer.
