### **ORDER :**

6) The promotion ordered in para-3 above is also subject to the condition that it shall be reviewed after completion of the process of final allocation of cadre strength, vacancies and employees between the successor States by the Government and the persons, so promoted meanwhile, shall not have any right on such promotion.
